- 1 Instituto Federal de Educação Ciência e Tecnologia da Paraíba (IFPB) and ILSC Education Group – ILSC Toronto (ILSC) agree to enter this Memorandum of Understanding (hereinafter referred to as MOU).
- 2 The purpose of this MOU is to promote and expand international cooperation, stimulate and support educational, professional and intercultural activities and projects of the two institutions, and its respective communities.

This MOU also sets forth the general and specific aspects of the agreement, with the understanding that on the basis of a regular review of activities, the document in both its general and specific content may be revised with mutual consent of both IFPB and ILSC.

- 3. General activity areas of mutual interest and concern may include but are not limited to the following:
 - Various educational programs
 - Educational Seminaries, work-shops and speeches
 - Distance learning programs
 - **Teacher Training**
 - Language Immersion, Summer-school programs
 - Portuguese Language, Literature and Brazilian Culture studies
- 4. As a condition to establish this agreement, the IFPB requests that for every fifteen students from the Federal Institute of Education, Science and Technology of Paraiba enrolled in ILSC Education Group/Greystone College, through Toronto First Steps, ILSC should offer one free fulltime English course of equal program length of the students to the group's coordinator.

The form of each cooperation act must be agreed separately by signed agreement of both parties.

5. Both institutions understand that this MOU is not exclusive and each institution is permitted to enter into such agreements as it deems fit with other universities and institutions.

DURATION

6. This MOU shall be valid for a period of three years from the date of signature and may be renewed for additional periods by written agreement of the institutions, signed by the duly authorized parties. During the initial three-year term (and subsequent extensions, if any), the parties shall consult at least annually to discuss the program, any problems that have arisen and opportunities for improvement.

EXCLUSIVE CLAUSE

7. Both institutions agree that all activities of mutual interest will be mediated by Toronto First Steps agency, the official representative of both institutions in their respective countries. Toronto First Steps is also responsible for program enrollment services, course program cancellations, refunds and any alterations during the exchange program. The agency should also provide accommodation, health care, visas, transfers, cultural activities and accompaniment of the student throughout their stay in the city they are received in. All questions and concerns should be taken up with the representative of Toronto First Steps.

TERMINATION

8. Either party may terminate this MOU at any time by giving a written notice 60 days before, signed by the Rector/General Director of the terminating party.

CONTACT PERSON

Because of the desirability of the implementing MOU activities in a systematic manner, IFPB and ILSC Education Group will designate a contact person assigned the responsibility of co-ordinating MOU activities in general terms. For IFPB, this will be Dr. Mônica Maria Montenegro de Oliveira, Head of International and Institutional Affairs and the Coordinator of Science without Borders and Language without Borders and for ILSC, this will be the school agent Danielle Alves Gomes Ferreira.
